The determination of an effective concentration of a therapeutic agent applied to a subject is important to many things such as the pharmacodynamics or pharmacokinetics of the agent, as well as to the determination of an appropriate dose or range of doses. Most currently available research or clinical trials, however, frequently report only one or two parameters. This may be due, for example, to the use of prohibitively large sample sizes with each test. The use of such large sample sizes may be necessitated, for example, by the fact that most drugs are not known to be highly specific in their physiological effect, thus necessitating the use of large study populations. Alternatively, the use of several parameters may require a prohibitively large number of subjects or clinical trials to reach a statistically significant result. These considerations may become even more salient when one considers the public health repercussions associated with the testing of a drug, wherein the public may be more willing to participate in clinical trials which involve testing fewer drugs rather than a larger number of drugs. Thus, it is clear that it would be most desirable to perform or conduct a clinical trial in a manner which allows the testing of fewer but more efficacious drugs. One conventional technique for measuring the effects of a therapeutic agent is through measurement of the subject's blood serum for its metabolic activity. For example, one such commonly used effector is the determination of blood serum levels of albumin, calcium and cholesterol. Generally, it is assumed that the levels of these above-listed conventional effectors, such as albumin or calcium, are affected in some known manner by the application of a drug or agent to a subject. As noted previously, however, the relationship between the metabolic activity of the subject and the drug or agent is not known or defined in any manner. Therefore, it is impossible to predict the pharmacodynamic or pharmacokinetic effects of a drug or agent using only the serum levels of one or more of such conventional effectors. In addition to the above-mentioned tests for conventional effectors, a number of other conventional physiological effector tests have been devised, including tests for glucose and other blood glucose levels, for blood pressure, for oxygen saturation, for immune function, for blood platelets or for biochemical tests of blood constituents. Many of the above-described conventional tests are designed to be performed on each subject in a particular study. There are many disadvantages to such conventional tests as well as to conventional clinical studies. For example, such conventional tests are typically time-consuming, laborious and expensive. What's New In?

The present invention relates to a stick gum package, and more particularly, to a package that can be opened to expose the stick gum without tearing the opening, and that prevents or reduces the leakage of stick gum components into the package. Stick gum is manufactured by the blending of gum base with chewing gum ingredients, such as sugar, high fructose corn syrup and a water solution of a hydrogenated vegetable fat such as a cocoa butter substitute. Stick gum is often packaged in a sealed container, and is commercially available in packages that are kept closed until the sticks are ready to be pulled out of the package. To enable the user to open the package at the point of purchase without tearing the package, stick gum packages are typically designed to permit at least partial opening of the package when the sticks are removed from the package. While packages can generally be opened without tearing, a significant problem with packages of stick gum is that significant amounts of chewing gum ingredients can leak from the package during the time that the package is open. Once the package is open, it typically cannot be resealed without compromising the integrity of the package. Therefore, the user must contend with the unpleasant issue of chewing gum leaking from the package, and then either having to scrape the chewing gum from the package, or discarding the chewing gum because of possible contamination by milk, sugar or other food items. Furthermore, the leakage of chewing gum ingredients from stick gum packages can cause the stick gum to lose its freshness, and can reduce its shelf-life. Several different methods for preventing or reducing the leakage of chewing gum ingredients from stick gum packages have been used. Some prior attempts to address the leaking problem have included a package having a seal that is designed to rupture under pressure exerted on the package. However, these packages have not been entirely successful, because the seal quickly ruptures after the package is opened. In addition, the ruptured seals can also cause the leakage of chewing gum ingredients from the package, and can create problems related to the strength and integrity of the package. Other prior packages have included a tamper-evident seal that requires the application of a force to break the seal, but that tamper-evident seals are usually not as secure as seal materials that can be used in stick gum packages. Another possible approach to reducing the leakage of chewing gum ingredients from stick gum packages is to form a tamper-evident seal in such a manner that it does not permit chewing gum ingredients to leak from the package until the seal has been removed.
